## RETURNS / DAMAGES

We have a no return policy. Damaged product must be reported within 72 hours of receiving merchandise. If any box in your shipment has exterior damage, be sure to indicate that at the time of receiving with your carrier. Report to us immediately with any contents damaged (if any). We can not file a claim with your carrier for credit if you do not establish with driver "boxed damage" at the time of delivery.

All sales of goods and/or services shall be final and payment in full shall be in accordance with all other terms, conditions, and agreements included with the credit application. No transactions shall be construed to be a consignment of sale goods and / or services. The person, company or legal entity executing the credit application is liable for any and all legal fees, services, and/or costs arising out of or associated with judgments rendered on behalf of Culturenik should Culturenik be forced to initiate court action against applicant. The Culturenik invoice shall be constructed in accordance with the laws of the State of Pennsylvania and any controversy or claim arising out of the invoice or its breach shall be litigated in a Court of competent jurisdiction in Pennsylvania and buyer submits to the jurisdiction of such court. Purchaser/Applicant shall be penalized on all past due balances exceeding 30 days to the extent of 18% A.P.R. (1.5%) month with such accruing on the 31st day account is delinquent.
